MEMORANDUM OF UNDERSTANDING (MOU) between

BGSIT & Aroha Technologies

This is an agreement between "BGSIT", hereinafter called ACU and "Aroha Technologies", hereinafter called AROHA.

I. PURPOSE & SCOPE

The purpose of this MOU is to establish Aroha Incubation Center at BGSIT premises under Computer Science Engineering Department. We will be reporting to Head, R & D Dr.RaviKumar GK, working with MTech students and plan to execute few social impact projects through BE, MTech and Ph.D. resources.

In particular, this MOU is intended to:

- Creation of incubation center.
- Working with students to build applications in Digital and Data technologies.
- Providing internship based on industry need and students' skill level.
- Mentoring and Monitoring BE, MTech students' in Data Analytics area.
- Analyzing BGS IP's and creation of applications which make a social impact.

Aroha technologies is a software services company which focuses on knowledge, Data and Digital Services. We are serving around 40 customers who are in Bangalore, Chennai, Mumbai, US and UK. We are a team of 100 people in the company as of today. Most of us in the company have technical background in Data and Digital technologies. We are in business from Jan 2006, we are located in Bangalore, India.

II. ACU- BGSIT RESPONSIBILITIES UNDER THIS MOU

ACU- BGSIT College will take care of the following responsibility as part of incubation center activities.

- Assigning Students to the incubation center.
- Providing required hardware and software's to students.
- Support Aroha resources who visit BGS IT campus
- Monitoring Aroha's work and provide feedback for constant improvement.
- Tracking the improvement happened to assigned students.

III. AROHA RESPONSIBILITIES UNDER THIS MOU

AROHA shall undertake the following activities:

- Conduct one-one sessions with assigned students, find out the strengths, skills and to see what kind of role they can play in Data and analytics area.
- Work with Head, R & D, Dr Ravi Kumar GK & his team to see how we can add value to the student's skill set
- Provide projects to work on, scenarios to explore in the related technologies.
- Capture all the activities which are performed as part of the incubation center and have a fortnightly call with the department in BGS.
- Conduct sessions on Data, Integration, Processing, MDM, Data Governance, visualization using different industry standard tools.
- Spend at least 10 hours with the team every month. We can consider around 25 resources in a year under this MOU.

IV. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

1. Modification

- Any modification can be included as an addendum to this MOU. For example, if this incubation center services were needed by any other department with in the university, university can write an addendum with their terms and clauses.

2. Termination

- Any party can terminate the MOU by informing to the stakeholders by giving 4 weeks' time by stating right reasons.

V. FUNDING

There is no commercials involved to mentor the BE, MTech Students who were enrolled into MTech Data and Analytics stream. We can provide Aroha services to selected 25 students from BGSIT for free.

VI. EFFECTIVE DATE AND SIGNATURE




This MOU shall be effective upon the signature of ACU and AROHA authorized officials. It shall be in force from March 01 2021 to March 01 2023.


